Cluster CIO Positions Posted

To ensure effective coordination and the delivery of world-class IT services, the DoIT operating plan organizes State agencies into **seven customer-focused and business-centric clusters**. Each of these will be led by a **Cluster Chief Information Officer (CCIO)**, who will report to the State CIO. Their core responsibility will be to accelerate modernization efforts for agencies within their particular cluster of agencies. Featured FAQ of the Week: When will a new organizational chart be available?

A new organizational structure will be rolled out after July 1, 2016. For the short term, most employees will maintain their existing reporting relationships and structures. There will be some organizational changes necessary to accommodate situations where maintaining current supervisor/direct report relationships may not be possible as employees are transitioning into DoIT.
