#### ISAC's Gift Assistance Program (GAP) Access Portal Enhanced

ISAC's Gift Assistance Program (GAP) Access Portal is the tool used to manage all ISACadministered scholarship and grant programs, including the disbursement of over \$400 million in scholarships and grants to Illinois students annually. Recently redesigned for

ease of use, some of the new features of the GAP Access Portal include simplified navigation, improved performance and an optimized overall user experience for future use with mobile devices. The Program Services and Compliance and Information Technology teams at ISAC worked together to improve the user experience for data inquiries and submissions, eligibility announcements and payment requests by educational institutions across the State of Illinois. ## Department on Aging Takes Another Step to Protect our Seniors



The Department on Aging acted quickly to implement an online Abuser Registry on June 27<sup>th</sup>. In just over a month and ahead of schedule, this subpart of the Adult Protective

Service Registry or Statewide Centralized Abuse, Neglect, Financial Exploitation, and Self-Neglect Hotline Act, mandated by court ruling, was available and accessible by the Department of Public Health. The DoIT-Aging team made this rapid progress possible by centralizing information used by several agencies to protect Illinois senior citizens who receive in-home and community based services.
